1) Amount of funding requested. Please give as much detail as possible and the dollar amount required for each element of the proposal. For new trail grooming requests fill out the Table *A. NEW TRAIL GROOMING MILES REQUESTED FOR 2024-2025* (on the last page of this application)

\$30,067.00 was the amount requested and granted for the 2023-24 season. It was based on the actual 2022-23 once a week grooming in the ongoing grant. The supplemental grant would then provide an additional grooming per week so that the Salmon Ridge Trail system would receive twice a week grooming.

- 2023-24 turned out to be a poor snow season and only half of the on-going grant was used. According to the grooming logs sent to the Commission, grooming the Salmon Ridge Sno-Park trails 2023-24 requires 6.5 hours of grooming at a rate of \$210/hr, and, 1.5 hours for Move-in/Lowboy Trucking at a rate of \$145/hr for a total of \$1,582.50 per grooming day and place. In order to groom Hannegan Pass Rd or White Salmon Rd it requires the additional Move-in/Lowboy Trucking at each place. During good snow seasons funding for once a week grooming has run out before the season is over. Thus the request for \$30,067.50 supplemental grooming.
- Please give a thorough description of the intended purpose of the proposed funding, including location, and affected Sno-Parks and trail systems.
 This proposal is a 2nd year supplemental funding request to cover the grooming costs in order to have

twice weekly grooming of the Salmon Ridge Trail system for the 16 week season, including White Salmon Rd, and, the dog friendly Hannegan Pass Rd which had been neglected for a couple of years. Salmon Ridge Sno-Park is located 46.5 miles NE of Bellingham off the Mt. Baker Hwy (SR542). The ongoing grooming grant funds have resulted in grooming only once a week and funds running out before the end of the season, leading to damaged groomed areas and poor user experience. During the 1st year of this supplemental grant (the 2023-24 poor snow season), of the 11 groomings, the trails received twice a week grooming three times mitigating any damage. Hannegan Pass Rd was groomed once and NNSC received the following email from the groomer.

"Hi Pete, we groomed part of the Hannegan trail on Sunday when we groomed. There is not enough snow there and then when we were on that trail someone drove up the trail and we had to pull them out..."

There is no gate on Hannegan Pass Rd to prevent vehicles from driving over the groomed trail – yet the USFS lists this in all the media as a groomed dog trail. We did find out this year that we can request signs from the USFS that say, 'no wheeled vehicles on groomed trails', for next season (2024-25) for Hannegan Pass Rd. We have also put in a formal request to the USFS for a gate at no expense to the Forest Service.

- Does your total request factor in the potential need for Snow Removal, Grooming, Sanitation, Education, Enforcement and possible need for dirt/land work?
 Yes. Snow removal, sanitation, education and enforcement are already covered by the on-going Sno-Park grooming grant. This request is for additional grooming funds to transition fully to twice a week grooming. The groomer has indicated an ability to provide for more grooming.
- 3) What is the estimated target audience (snowmobilers, dog mushers, cross country skiers, snowshoers, others) and what percentage do you anticipate each use at? The target audience would be cross country/nordic skiers and snowshoers, evenly divided at 48% skiers, 48% snowshoers and 4% skijorers.
- 4) Why is this project essential? (New or expanded area, local economic impacts, recreational demands)

Salmon Ridge Trail System is a vital winter recreation site maintained by the Nooksack Nordic Ski Club (NNSC) whose members donated the equivalent value of \$21,814.41 in volunteer work and mileage. Even during this poor snow season we have a car count of 2,800 from Dec 1, 2023 thru Mar 30, 2024. This means potentially there were between 2,800 and 7,000 people using the Sno-park. Maintaining this Sno-Park with twice a week grooming will continue to help diversify the places for winter recreation and alieviate some potential for overcrowding. It is the only tracked and groomed cross country ski area north of Stevens Pass.

NNSC has had a great working relationship with USFS since the 1980s educating the public and maintaining and improving the trail system. Salmon Ridge Sno-Park has separate but integrated snowshoe trails. However, because it is an open access Sno-Park, many snowshoers walk on the groomed surface of the ski trails and damage them. Low to no grooming on Hannegan Pass Rd has brought dogs onto the other groomed trails. Funds are needed to groom twice weekly to repair the damage and maintain the integrity of the groomed trail system for skiers. Otherwise, the area with it's hills become dangerous for skiers. Declining conditions with the once a week grooming would result in unsatisfied skiers and declining use of this trail system causing people to go to other already crowded ski areas.

5) Briefly describe the recreational benefits of the proposal. How will this funding improve the recreational experience of visitors? What types of recreational uses will be enhanced? A great example of the benefits (recreational to the users and financial to businesses) is that NNSC partners with the City of Bellingham with their recreational outing program on Our Ambassador Days, providing cheer, hot chocolate, education about and maps of trails, types of skis, information on need for, as well as providing the sale of Sno-Park Permits, snowshoeing and even some free skiing instruction that day. The users provide their own equipment thus benefiting local businesses (ski and restaurant) and they get a great recreational experience.

Twice a week grooming makes for happier and safer skiers – providing a great surface for their recreational outing/exercise and much safer surface for less potential for injury from snowshoe and dog damage.

The completed Connector trail that links White Salmon Rd to Salmon Ridge Sno-Park has accomplished a couple of things: 1 It has opened up possibilities for White Salmon Road to be in consideration of a future Sno-park revenue source for the Commission and, 2. It provides a

groomed White Salmon road - to backcountry skiing - to groomed Salmon Ridge trail experience. Tired skiers coming down to Salmon Ridge from White Salmon Road need the twice grooming trail for a safe experience. A minimum of twice a week grooming will provide at least adequate groomed trails currently.

Yes. The Nooksack Nordic Ski Club has been committed to the stewardship of the Salmon Ridge Trail System since the 1980's. We share the core value of providing access to a variety of winter recreation for the public to enjoy by including trails for snowshoers, dog lovers, back-country and groomed trail skiers as well as a place for families to simply play in the snow.

One way we show we are responsive to recreational demand is by volunteers clearing downfall across any groomed trail as soon as possible. Another way is by listening to the users and requesting supplemental funding so we can have twice a week grooming. With our Ambassador Days we encourage responsible use of the trails and provide a welcome to users. We know there is an increased need for parking and would love to have the full parking lot plowed when funds allow.




Gerbil Loop

2) Please give a thorough description of the intended purpose of the proposed funding, including location, and affected Sno-Parks and trail systems.

The purpose of this proposal is to expand the Asahel Curtis Sno Park to the newly constructed Franklin Falls Trailhead 2.5 miles up Forest Road 58 from the existing Asahel Curtis Sno-park. Both Asahel and Franklin falls Sno-Park are located off I90 at exit 47 right bellow Snoqualmie Pass. The recently constructed Franklin Falls parking lot and day use area has 177 parking spaces in the summer and likely around 100 in the winter. The Trailhead has hills for sledding, an adjoining campground, ample space for general snow play, and a short 2-mile trail to Franklin Falls for winter recreation. This proposal also asks for the support of higher GS level employees. To have Forest Protection Officers out in the field the Forest Service now mandates employees be permanent. The I 90 Corridor has recently hired 5 permanent seasonal employees. The proposed increase in personnel funding would go to keeping two of these permanent seasonal employees on through the winter. The last addition to the proposal is the addition of one more double vault toilet to be pumped at the end of the winter season.

Over the last three years of managing the Asahel Curtis Sno-Park it has become clear that most visitors are using the area to park and then walk the 2.3-mile road to the Franklin Falls Trailhead. The remaining visitors are looking for an area for snow play. Currently neither Ashel Curtis nor Annette offers a great opportunity for snow play. The expansion to the Franklin Falls trailhead would meet a large need in the area for snow play and a short snowshoe hike that holds snow. The demand for this type of recreation can be seen in the data collected from the 2021-22 winter season.

During the 2021-2022 winter season, using Trafx vehicle counters the Snoqualmie Ranger District's Winter Snow Rangers counted an average of 72 vehicles per day with peak usage on Saturdays and Sundays. On Saturdays we averaged in excess of 175 vehicles per day and 125 vehicles on Sundays. We began collecting this data in mid-December when the snow first began to accumulate. In December our Winter Snow Rangers counted 286 vehicles and checked 174, observing a 62% compliance rate. 136 public contacts were provided and 76 warnings were issued. 374 vehicles were counted in January and 236 were checked. 424 contacts were made, 61 warnings issued and 27 citations were issued. In February 474 vehicles were counted, 207 vehicles were checked for a 65.3% compliance rate. 191 public contacts were made as five warnings were issued and 83 citations were written. 160 vehicles were counted in March with 116 being checked for a 73% compliance rate. Three warnings and 22 citations were issued. 84 public contacts were made. In total this program generated an approximate \$1,300 of additional revenues in day-passes sold in February and March for Washington State Park's Sno-Parks program.

During the 2022-23 winter season we did not collect Trafx data but will restart data collection in 2024-25. The same trends from the 2022-23 winer season were noted again with most the use along I90 going to Franklin Falls. During this year's low snow year, the Franklin Falls Trailhead held onto snow from December to March while Asahel and Annette were intermittent throughout the season. We were also not able to have Forest Protection Officers out in the field in 22-23 due to the limitations of seasonal employees.

a. Does your total request factor in the potential need for Snow Removal, Grooming, Sanitation, Education, Enforcement, and possible need for dirt/land work?

This request accounts for snow removal (estimate came from current contractor), sanitation, education, and enforcement. There is no need for dirt work before or after for this proposal.

-The snow removal estimate is quite large at \$30,600. This is broken down at a cost of \$900 an hour for 2 hours per plow. We are estimating that the area will need to be plowed 17 times

throughout the winter. The high hourly rate comes from needing a 35,000LB loader with a 16' wide blade. This would allow the contractor to stack the snow high enough and allow them to move the snow even in a large storm.

-Sanitation, \$1260 for pumping a double vault CXT toilet. The Forest Service will provide cleaning supplies, toilet paper, and other cleaning materials. Pumping of the Annette site now costs \$750.

-This request would fund three Sno-Park Rangers capable of both enforcing permits, but also educating the public.

3) What is the estimated target audience (snowmobilers, dog mushers, cross country skiers, snowshoers, others) and what percentage do you anticipate each use at?

-The target audience for the Franklin Falls Sno-Park would be snowshoer's, snow play (sledding and more!), hikers, backcountry skiers, and cross country skiers on the ungroomed FRD 58. Future target audiences could include nordic skiers for groomed/tracked route along FSR 58 past the Franklin Falls trail head. Based on current use, we anticipate approximately 70% snowshoer's to Franklin Falls and 30% snow play. As the public's awareness of this winter recreational opportunity grows, we anticipate snowshoeing and snow play in the area to become more and more popular.

4) Why is this project essential? (New or expanded area, local economic impacts, recreational demands)

Sno-Park parking, snow play, and general winter recreational opportunities are in high demand along the I-90 corridor. Over the last 3 years it has become clear that the public wants access to Franklin Falls and an area for snow play with steady snow. The Franklin Falls parking lot provide these opportunities! With its proximity to Seattle and presence as a known commodity, this expanded Sno-Park on the I-90 Corridor and Snoqualmie Ranger District would likely prove to be financially beneficial for Washington State's Winter Recreation Sno Park program. The infrastructure is in place to have the State Park Fee machine brought down from outside the Firehouse at Snoqualmie Pass to provide a point of sale option for the area.

The additional funding for Sno-Park employees would go to keeping the Forest Protection officers a part of the Sno-park program on the District. In order to write tickets for the USFS, employees now need to be permanent as opposed to seasonal. The Snoqualmie Ranger District now has 5 permanent seasonal employees funded from March to November. The additional funding would go to keeping two of these employees on through the winter. This is an essential aspect of opening up more access to the public. This new Sno-Park would take active management to avoid public safety issues along the road and parking lot. Without the additional funding for personnel we will not have the ability to write tickets. 5) Briefly describe the recreational benefits of the proposal. How will this funding improve the recreational experience of visitors? What types of recreational uses will be enhanced?

This proposal will open a large area for snow play as well as improving access to Franklin Falls with a short snowshoe route. Over the last three years our Sno-Park Rangers have reported back to us that most of the use around exit 47 is for snow play and visiting Franklin Falls. We are currently not doing a great job of offering these two options. By funding two Forest Protection Officers we would be able to adequately manage and enforce the area.

-Yes, landowner Permission is granted through the District Ranger Line officer of the Snoqualmie Ranger District/Mt Baker-Snoqualmie National Forest where all winter recreation Sno-Park operation will occur.

-The Snoqualmie Tribe was consulted as a co-steward of the area and was in favor of using this area as a winter recreation site due to the contained impact of the site.

8) Is Landowner Permission (Winter Recreation Use Permit) signed by Landowner attached to this application? (Landowner Permission must be obtained prior to start of season)

-The Franklin Falls Trailhead is Federal Land. There are a handful of recreation residence in the Denny Creek area that are under Forest Service Permits, but owners of these cabins understand that their cabins sit on public land and that access to these lands to the public will not be denied.

9) If adjacent homeowners/housing developments/landowners will be impacted by the proposed action, do they support the proposal?

Recreation residents are under a Forest Service Special Use Permits adjacent to Franklin falls and do not hold private property rights. There have been discussions with homeowners along the County administered section of the road and the hope is by pushing people up to the Franklin Falls Parking lot we will reduce impacts of recreators walking by private property.

10) Describe what communications were conducted to obtain homeowners/housing developments/landowners support.

In the Spring of 2023 Snoqualmie District Recreation leadership met with King County and private landowners along FRD 58 to discuss opening the area to winter recreation. All impacted parties have been heard and met with along FRD 58. The proposed area for the Sno-Park is all on federal land.

No, all environmental analysis has been performed by the agency specialists and approved by the District Ranger/Line Officer.

This proposal is consistent with the elements of the strategic plan. Below are a few specific ways this Sno-Park would move the States strategic plan forward.

1. Recreational access opportunities are responsive to user demands, while reflecting sensitive environmental stewardship.

-Over the course of three years of running Asahel and Annette Sno-Parks it has become clear that the public wants access to Franklin Falls and open areas for snow play. This proposal would provide the recreation opportunities the public is seeking in an already impacted site. The Snoqualmie Tribe has been consulted and they are in support of funneling winter recreation into Franklin Falls as it is already heavily impacted from I90 and summer recreation.

3. There is adequate separation of incompatible or conflicting recreational uses.

- This Sno-Park will increase non-motorized recreation opportunities only. There should be zero user conflicts in the area as the uses are limited by terrain and access. Sno-Park Rangers will be on site to ensure that conflicts are quickly abated, and non-permitted users are moved on.

2. The Program has viable planning functions.

-The Snoqualmie Tribe was consulted as a co-steward of the area and was in favor of using this area as a winter recreation site due to the contained impact of the site.

-Partners and winter advocacy groups have been consulted with and a letter of support has been signed by Cascade Backcountry Alliance, Washington Trails Association, The Mountaineers, Mountains to Sound Greenway, Kongsbergers Ski Club, and the Washington Ski Touring Club.

Upper-Level Objective 3

1. Safety, education, and resource stewardship are high priorities.

-By funding 2, GS-07 Forest Protection Officers the Sno-Parks along I90 would have the staffing to enforce, educate, and provide a safe and clean experience.

13) Has the Area Winter Recreation Program Advisory Committee member been advised of this request?

Dear Winter Recreation Advisory Council,

Cascade Backcountry Alliance is writing on behalf of a coalition of outdoor recreation groups in Washington representing 40,000+ avid recreationalists. We express our full support for the development of the Denny Creek Sno-Park along I-90.

Our members and volunteers are a passionate, engaged, and knowledgeable community that care about the outdoors and work to protect the outdoor experience for current and future generations. Increasing accessibility to the outdoors for new users is a core value for our groups and one of the reasons we are excited about the development of a sno-park at Denny Creek.

We understand that the Denny Creek sno-park will replace the current sno-park at Ashael Curtis. While our members have greatly enjoyed access to Ashael Curtis, the community has noted several issues including: proximity to the freeway, limited parking and a long approach to the area's main attraction, Franklin Falls. The current hike is around 6.5 miles round trip, which is a potentially challenging undertaking for families and beginner winter travelers.

Denny Creek is expected to have 170 parking spots, which we believe will significantly help alleviate known crowding and parking scarcity issues at Snoqualmie Pass. The new sno-park location offers better snow play opportunities for families and people interested in having a winter outdoor experience without investing in expensive technical gear or advanced avalanche training. Snow play has the largest, most diverse potential use base at the new sno-park and is an easy entry point to increasing accessibility to the winter outdoors. In addition to snow play opportunities it will provide entry-level snowshoeing and winter hiking opportunities.

We believe this is especially important because 1)The rate of growth of the backcountry ski and snowshoe community continues to skyrocket; <u>Outdoor Industry Association</u> cited a 20% increase in snowshoeing between 2021 and 2022 winter seasons. And 2) the Gold Creek Valley restoration project is moving forward which will likely lead to a 5-7 year closure of the very popular snowshoe loop at Gold Creek Sno-Park. Denny Creek Sno-Park development will provide a great opportunity to support new winter users and Gold Creek pond users to get outside safely and responsibly.

Per the *Seattle Times* (February 29, 2023), roughly ¼ of sno-park sales come from the City of Seattle with another 10% from other cities along the I-90 corridor (Issaquah, Sammamish, Kirkland, Bellevue, Redmond). Many of our members live along the I-90 corridor and were ecstatic to see the development of the Lake Annette Sno-Park last year. We believe devoting more resources to winter recreation planning efforts along the I-90 corridor is smart and sustainable. Denny Creek Sno-Park is a good example of a project with limited impact on the environment and maximum impact for improving winter frontcountry and backcountry access.

We are thankful for WRAC's continued leadership in the Washington recreation arena. We understand the complex funding and policy associated with the development of new sno-parks and are grateful for your consideration of Denny Creek for a future sno-park location.



This is a second year request for the Stemilt Basin Non-Motorized Sno-Park located near the intersection of the Orr Creek Roak and the Stemilt Creek Road. The request is primarily for snow removal/plowing. About 100 yards of the Orr Creek Road must be plowed from the county road (Stemilt Creek Road) to reach a small plowed parking lot capable of parking about 8 cars on property owned by Washington Department of Fish and Wildlife (WDFW). WDFW has granted permission for this lot to be plowed for winter, non-motorized visitors coming to snowshoe, cross-country ski, walk etc. Some of the funds will also be used for the seasonal rental of a seasonal porta-pottie as well.

a. Does your total request factor in the potential need for Snow Removal, Grooming, Sanitation, Education, Enforcement and possible need for dirt/land work?

The 'trails' beyond the plowed parking area are gated forest roads that will NOT be machine groomed but 'groomed' through use. As such, none of the proposed funding would be used for grooming.

3) What is the estimated target audience (snowmobilers, dog mushers, cross country skiers, snowshoers, others) and what percentage do you anticipate each use at?

Snowshoers 30%, cross-country skiers 20%, dog walkers and winter walkers 25%, family snowplay 15%, backcountry skiers 10%.

4) Why is this project essential? (New or expanded area, local economic impacts, recreational demands)

Wenatchee has an active outdoor populace. Many people move here or choose to stay here because of our immediate access to the outdoors. Quick access to the outdoors is especially true of our snow-free months when the surrounding foothills trails accommodate hikers, runners, and mountain bikers. Most of these foothills trails, however, close between December 1 and March 30 to help the mule deer wintering here. The proposed Sno-Park would help fill the void left by the winter closure of our foothills trails and would be well received by our active populace.

5) Briefly describe the recreational benefits of the proposal. How will this funding improve the recreational experience of visitors? What types of recreational uses will be enhanced?

The attraction of this particular Sno-Park is its proximity to Wenatchee AND its relatively gentle topography. This is a place where beginner snowshoers, beginner backcountry skiers, intermediate cross-country skiers, parents wanting to play in the snow with their children can all come to safely recreate. The gentle topography helps beginners learn how to use the awkward boards strapped to their feet, and there is virtually no avalanche hazard in and around the proposed parking area. None of this winter use will happen during a snowy year because there is simply no place to park. The purpose of this proposal, then, is to provide parking so winter recreationalist can gain access to this area.

Yes. Two local non-profit organizations (WenatcheeOutdoors and El Sendero Backcountry Ski and Snowshoe Club) worked with the local branch of WDFW in the creation of non-motorized, winter recreation areas in the Stemilt Basin during two, multi-year, public planning processes (Naneum Ridge Recreation Plan and the Stemilt Basin Recreation Plan) and the agency was in full support of these areas. Last autumn, WDFW did some land sculpting to create the parking area where this Sno-Park is located.

8) Is Landowner Permission (Winter Recreation Use Permit) signed by Landowner attached to this application? (Landowner Permission must be obtained prior to start of season)

No. We have been in contact with our local WDFW contact (Pete Lopushinsky) who worked with us during the public planning processes and who helped us with our the establishment of the Sno-Park last year. He will have the landowner permission submitted separately.

Adjacent landowners are not affected by our proposal.

There are no homeowners near this Sno-Park and the properties used by the snowed-over roads our sno-park provides access are all undeveloped lands owned by WDFW.

No. All permitting requirements associated with the minimal earth sculpting that took place in the creation of our parking area were completed by WDFW last year before that sculpting took place.

Yes. We were in contact with Peter Valaas during our first-year request for this sno-park and he knows we are applying for second-year funding.

Last year Andy Dappen represented the proposal at the funding meeting and, if he is available at the time this year's meeting takes place, he intends to represent this year's request. If he is unavailable at that time, a board member from WenatcheeOutdoors will represent our proposal.

The Warden starts the morning by driving to one of the two sno-parks. They conduct a road conditions check, letting the Mount Tahoma Trails Association operator know if plowing needs to be done. Then they go through the parking lots and start checking that all vehicles have sno-park passes. If a vehicle doesn't have a pass, they will leave a warning notice. They talk with people arriving to the parking lots, and answer any questions they have about the area. They help notify arriving visitors of how muct parking remains at the lots. They repeat this series of actions at the second of the two sno-parks. The Warden takes all required DNR classes and safety trainings. The Warden was newly hired in December 2023, and currently is in training to receive DNR Limited Commission Authority. During the 2023-2024 winter season, they were not authorized to write citations due to lacking this Authority They will be authorized to write citations once the training is complete, anticipated to be completed by the start of the 2024-2025 winter season. The Warden is on site for any permitted recreation events or emergencies that occur in the project area. They also attend the Mount Tahoma Trails Association board meetings to foster communication with the non-profit that assists in managing the Mount Tahoma Trails System.

b) Describe your complaint process (how are they recorded and tracked), the number and kind of complaints received, recurring themes and issues, and any known conflict between user groups.

Complaints make their way to our South Puget Sound Region headquarters via telephone or email. The complaints are then routed to our Recreation Manager for documentation and response. Our Region received no documented complaints this season from the public regarding the sno-parks or snow trail system.

14. How is on the trail enforcement provided? What would you need to make on the trail enforcement more effective?

Trail enforcement is done via snow shoe, ski or by tracked UTV (If needed). This year we did not use the tracked UTV. The enforcement was mainly done by snow shoe/ski into the trail system.

15. How is Sno-Park enforcement provided? What would you need to make Sno-Park enforcement more effective?

The Warden has a State issued DNR truck with 4WD to get to the sno-parks. Upon arrival the Warden can visually check the passes on vehicles, and give any information to the public in the area. The Warden is able to provide visitors with useful information about the conditions of the roads, sno-parks, and ski trails prior to embarking on their trip. These sno-parks are highly frequented by new visitors, so being able to provide them with information about the area's use is highly beneficial to other users, the land manager, and volunteer ski patrol. The Warden would also be able to provide information about local goods and services that may be needed by visitors. The Warden is responsible for enforcing sno-park pass compliance through a combination of verbal warnings, written warnings, and citations. Pass enforcement ensures that non-pass holding visitors are not taking up limited space in the sno-parks that a valid pass holding visitor could use. The Warden will have the option to give non-compliant users the oppurtunity to purchase a pass in lieu of giving them an infraction. If users do not follow up with the Warden showing proof of purchase of a pass, then the Warden can issue an infraction through the mail. This strategy of dealing with pass enforcement has been used in other DNR landscapes, and has lead to increased pass purchases, and thus brings in more funding for the sno-park program.



Liability of owners or others in possession of land and water areas for injuries to recreation users—Known dangerous artificial latent conditions—Other limitations

(1) Except as otherwise provided in subsection (3) or (4) of this section, any public or private landowners, hydroelectric project owners, or others in lawful possession and control of any lands whether designated resource, rural, or urban, or water areas or channels and lands adjacent to such areas or channels, who allow members of the public to use them for the purposes of outdoor recreation, which term includes, but is not limited to, the cutting, gathering, and removing of firewood by private persons for their personal use without purchasing the firewood from the landowner, hunting, fishing, camping, picnicking, swimming, hiking, bicycling, skateboarding or other non-motorized wheelbased activities, aviation activities including, but not limited to, the operation of airplanes, ultra-light airplanes, hang gliders, parachutes, and paragliders, rock climbing, the riding of horses or other animals, clam digging, pleasure driving of off-road vehicles, snowmobiles, and other vehicles, boating, kayaking, canoeing, rafting, nature study, winter or water sports, viewing or enjoying historical, archaeological, scenic, or scientific sites, without charging a fee of any kind therefor, shall not be liable for unintentional injuries to such users.

(2) Except as otherwise provided in subsection (3) or (4) of this section, any public or private landowner or others in lawful possession and control of any lands whether rural or urban, or water areas or channels and lands adjacent to such areas or channels, who offer or allow such land to be used for purposes of a fish or wildlife cooperative project, or allow access to such land for cleanup of litter or other solid waste, shall not be liable for unintentional injuries to any volunteer group or to any other users.

(3) Any public or private landowner, or others in lawful possession and control of the land, may charge an administrative fee of up to twenty-five dollars for the cutting, gathering, and removing of firewood from the land.

Liability of owners or others in possession of land and water areas for injuries to recreation users—Known dangerous artificial latent conditions—Other limitations

(1) Except as otherwise provided in subsection (3) or (4) of this section, any public or private landowners, hydroelectric project owners, or others in lawful possession and control of any lands whether designated resource, rural, or urban, or water areas or channels and lands adjacent to such areas or channels, who allow members of the public to use them for the purposes of outdoor recreation, which term includes, but is not limited to, the cutting, gathering, and removing of firewood by private persons for their personal use without purchasing the firewood from the landowner, hunting, fishing, camping, picnicking, swimming, hiking, bicycling, skateboarding or other non-motorized wheelbased activities, aviation activities including, but not limited to, the operation of airplanes, ultra-light airplanes, hang gliders, parachutes, and paragliders, rock climbing, the riding of horses or other animals, clam digging, pleasure driving of off-road vehicles, snowmobiles, and other vehicles, boating, kayaking, canoeing, rafting, nature study, winter or water sports, viewing or enjoying historical, archaeological, scenic, or scientific sites, without charging a fee of any kind therefor, shall not be liable for unintentional injuries to such users.

(2) Except as otherwise provided in subsection (3) or (4) of this section, any public or private landowner or others in lawful possession and control of any lands whether rural or urban, or water areas or channels and lands adjacent to such areas or channels, who offer or allow such land to be used for purposes of a fish or wildlife cooperative project, or allow access to such land for cleanup of litter or other solid waste, shall not be liable for unintentional injuries to any volunteer group or to any other users.

(3) Any public or private landowner, or others in lawful possession and control of the land, may charge an administrative fee of up to twenty-five dollars for the cutting, gathering, and removing of firewood from the land.

(4)(a) Nothing in this section shall prevent the liability of a landowner or others in lawful possession and control for injuries sustained to users by reason of a known dangerous artificial latent condition for which warning signs have not been conspicuously posted.

(i) A fixed anchor used in rock climbing and put in place by someone other than a landowner is not a known dangerous artificial latent condition and a landowner under subsection (1) of this section shall not be liable for unintentional injuries resulting from the condition or use of such an anchor.

Dear Committee Members,

Please consider this letter of support for ongoing and new funding for grooming at the combined Erling Stordahl/Cabin Creek Snow Parks.

The combined trail systems at Cabin Creek (CC) and Erling Stordahl (ES) cover approximately 24 miles of groomed trails. While ES is relatively short (3 miles), The Cabin Creek system, including the south loop (snowshoe trail) offers a great variety of trails for beginners; the road which is mostly flat; to the four miles of the more advanced and hilly Viking course; and the five mile climb to the top of the Amabilis Mountain. At a top elevation of 4,500 feet, Amabilis also offers an excellent opportunity for early season skiing.

ON-GOING FUNDING: We hereby request on-going funding for 2024-25 in the amount of \$159,411, which is the same amount approved for the 2023-24 Season.

ADDITIONAL GROOMING FUNDING: CC/ES is groomed by a private contractor. The contract issued in November of 2023 significantly increased the hourly rate for grooming which in turn reduced the number of grooming hours available for the same amount of funds. The Committee approved a request for \$15,000 for additional grooming for the 2023-24 Season, which was year two for the additional grooming request. We hereby ask that the Committee again approves an application for \$15,000 for additional grooming.

Thanks to the willingness of USFS to close down Cabin Creek to vehicular traffic and allow grooming with as little as 4 - 6'' of snow, we were able to commence grooming on December 2^{nd} 2023. This allowed for the groomer to pack down a base by utilizing lighter grooming equipment with rubber tires. We had quality skiing from the early days of December to the very end of March. As a matter of fact, the best skiing in the state last season was at Cabin Creek.

Due to the higher hourly rate of the new grooming contract, we had fewer hours of grooming available and made various adjustments in the grooming schedule to make the budget not only stretch to the end of the season, but also provide grooming at least five days a week throughout the season. Adjustments included reducing the number of days of grooming up the Amabilis Mountain and only doing one grooming pass on days of challenging snow conditions. By making these adjustments, we compromised the grooming quality and reduced the number of grooming days towards the end of the season.

We believe the combined amounts of on-going and additional grooming funds of \$174,411 to be the absolute bare minimum of funds required to provide a reasonable level and frequency of grooming at ES/CC.

This funding proposal is consistent with the elements of the Winter Recreation Strategic Plan in several areas and approval of the funding request would be consistent with:

- 1. The Winter Rec Program is responsive to the recreational demands of the public
- 2. Capturing and expressing the desires of the users and building stronger relationships with users
- 3. Provide guidance to the Program in meeting increasing recreational demands, especially in the I-90 corridor

These highlight areas in which the Strategic Plan (page 3) clearly advocates for this kind of funding.

Lastly, the Kongsberger members in addition to other members of the public continue to put in 2,000+ volunteer hours at Cabin Creek and Erling Stordahl every year. The trail work and maintenance at these parties is a critical component to why the private contractor is able to provide skiing at Cabin Creek on only a few inches of snow.

The beginning of last season was particularly challenging with a number of fallen trees. Kongsberger members were out in large numbers to surface and remove fallen trees. This effort greatly reduced the amount of trail maintenance required by the contractor, saving money for grooming rather than tree removals.







This project is essential to maintain the level of grooming we are seeking grant funds for at the affected sno-parks. The current snowmobiles have had multiple years of mechanical issues that resulted in grooming not occurring over multiple days/weeks. Coupled with supply chain issues in obtaining parts, the grooming program was not effective.

If the Naches District is going to continue to provide this much desired grooming service of snow trails, our equipment needs to be replaced. Malfunctioning equipment can also result in lost time, present safety issues when riders are stuck on the trail in cold temperatures, and could cause other injuries as a result of removing a disabled machine from the trail.

This winter program also draws users from around the region that provide economic benefits to local businesses in the area, specifically those that are located within the corridors where the sno-parks/trail systems are located.

1). Amount of funding requested. Please give as much detail as possible and the dollar amount of each element.

Additional funding to support grooming the 1.06 mile long Lake Keechelus Boat ramp road (NF 9070-219) on Saturdays from January to the end of the grooming season. Estimated cost of \$3,500 for grooming by the Lake Easton State Park staff (full expenses for staff time and equipment operations).

2). Please give a thorough description of the intended purpose of the proposed funding, including location, and affected Sno-Parks and trail system.

This project is essential to building an expanded and more diverse nordic skiing/snowshoe/snow play experience for all citizens that use the Hyak Sno-Park, one of the most popular in the State. The expansion will help reduce user conflict by spreading out users on an expanded trail system where users can access multiple branch trails such as the Common Corridor, the High Horse Trail, Roaring Ridge Backcountry as well as the use of Keechelus Lake when it is frozen by ice skaters and paragliders. This expansion will provide more inclusiveness especially on days when organizations run their programs at Hyak Sno-Park, including but not limited to Outdoors for All, REI Adventure Outings, The Mountaineers, Washington Alpine Club, Washington Ski Touring Club, and the Snoqualmie Nordic Club that maintains a warming hut on the expanded trail system. We feel that the user experience will be enhanced due to the ability to spread out onto new trails from the narrow and heavily used Palouse to Cascades Trail.

a. Does your total request factor in the potential need for Snow Removal, Grooming, Sanitation, Education, Enforcement, and possible need for dirt/land work.
Yes, no additional expenses are required other than grooming the 1.06 mile Boat Launch Road (NF 9070-219). The regular operations of the Hyak Sno-Park and the Palouse to Cascades Trails have been discussed with State Parks staff and they do not anticipate any additional costs. The return on investment for this project is unmatched as it only requires grooming hours with no additional expenses for a greatly expanded trail system in a highly desirable location. The SNC provides volunteers to maintain the trails, clean up trash, erect informational signage, and provide a warming hut in the Keechelus Trailhead parking lot one half mile from Hyak Sno-Park.

3). What is the estimated target audience (snowmobilers, dog mushers, XC skiers, snowshoers, others) and what percentage do you anticipate of each?

This will be a multi-use trail open to nordic skiers (40%), snowshoers (45%), backcountry skiers (10%), boot hikers for snowplay (5%), and the rest ice skaters and paragliders (<1%). 4). Why is this project essential? Recreational demands?

This project is essential for meeting the needs of a growing, diverse, and underserved population seeking winter recreation in an environment where access and opportunities are

shrinking. We feel this is a cost effective and responsible way to increase infrastructure and provide additional opportunities for all users in the I-90 corridor who will be impacted by the pending closures of the Summit East nordic lower trail system and the Gold Creek Ponds for recreational use. Hence we are initially requesting funding for grooming on Saturdays which are the busiest day of the week with regularly scheduled events by Outdoors for All, REI Adventures, The Mountaineers, Washington Ski Touring Club, and the Snoqualmie Nordic Club to name a few.

5). Briefly describe the recreational benefits of the proposal. How will this funding improve the recreational experience of visitors? What types of recreational uses will be enhanced? The Sno-Parks along I-90 are severely impacted by limited groomed trails for accessing scenic vistas, accessing backcountry areas, and for open spaces like what is afforded at the Lake Keechelus Boat Launch. Granted it is only one mile of grooming but even this distance limits many users from experiencing the scenic views of the Cascade Crest. We anticipate a large increase in demand due to the pending closure of the Gold Creek Ponds at Gold Creek Sno-Park and it is our goal to provide a mitigation for the loss of this extremely popular recreation area.

6). Is the requested funding one time only or ongoing? On Going.

The Snoqualmie Nordic Club paid for the grooming of the Boat Launch Road in 2010, 2011, 2012, and 2013 with Club Funds. The Club applied for Winter Sports funding in 2014 and 2015 but low snowfall canceled that year's grooming, The club was awarded funding in 2016 for grooming. The Club did not apply for grooming funds from 2017-2023 and held the Jente Loppet event on the Palouse to Cascades Trail when snow was available. The future goal is to include the grooming in the yearly grooming budget as part of the State Park grooming budget (Lake Easton would apply for funding with their annual request).

7). Has landowner Permission been obtained?

Special Use Permits to use Forest Road 9070-219 are in process with the USFS Cle Elum Ranger District.

8). *Is Landowner Permission signed by Landowner attached to this application?* Pending Special Use Permits.

9). If adjacent homeowners/housing developments/land owners will be impacted by the proposed action, do they support the proposal?

SNC held a conference call on April 30th with John Ernster, Regional State Park Manager and Andrew Kerlee, State Park Ranger for Hyak and the Palouse to Cascades Trail to discuss the use of the State Park property and any impacts to the adjacent property. They are in agreement to use the State Park property for access to the Boat Ramp Road at two locations where there are roadways connecting to the groomed Palouse to Cascades Trail. They supported the proposal to groom the Boat Launch Road and asked SNC to coordinate the grooming request with Joshua White, Lake Easton State Park Construction and Equipment Manager.

There is no direct impact to residents of Hyak Estates or to residents on State Route 907. The Boat Launch road is bermed at the junction with the Hyak Sno-Park entrance in the winter so there is no vehicle traffic on this road when snow is present. The USFS opens the gate on the Boat Launch road for non motorized recreation after the berm is in place.

10). Describe what communications were conducted to obtain homeowners/housing developments/ land owners support.

In prior years SNC has received Special Use Permits from the Mount Baker/Snoqualmie National Forest North Bend Ranger District. Steven Johnson, Nikolai Ferrell, and Brian McNeil provided letters of support for grooming the road. Since then the management of the area has changed to the Wenatchee National Forest Cle Elum Ranger District. We are requesting Special Use Permits from staff in Cle Elum.

11). Are there any permitting or environmental review requirements associated with the implementation of the proposal?

There were no review requirements in prior years as the road is open to motor vehicle use by the public when not closed by snow for winter recreation. The road is a high standard, two lane with wide shoulders and pull outs, paved, with guard rails, and used to access the boat launch on Lake Keechelus when the road is open. The road would only be groomed after the snow depth reaches the standard of 24 inches on the ground. If equipment and staff are available the road surface can be rolled and packed with as little as six inches of snow cover. This helps preserve the snow and provides a safe surface for recreation.

No additional permits or environmental review is necessary under the guidelines of the US Forest Handbook (FSH 1909.15) Chapter 30 NEPA Categorical Exclusion, 36 CFR, 220.6 (d) (4) Repair of roads and maintenance of roads and trails.

12). Is the Funding Proposal consistent with the elements of the Winter Recreation Strategic Plan? Explain How:

We believe this funding proposal is consistent with the elements of the Winter Recreation Plan. It is our understanding that the mission of the Winter Recreation Program is to provide "a variety of snow-based winter recreation opportunities to the public while protecting natural and cultural resources." We also understand that the vision of the Winter Program is a "well managed and respected program that is effective and efficient in providing service that meets the demands of the public."

Given this, we believe that as the demand for non motorized recreation in Washington State increases due to popularity and population growth there will be increased demand along I-90 for safe high quality groomed trails. We support the State Program as partners in providing that by adding the additional grooming of the boat launch road as it will bring the program one step closer to meeting that anticipated demand.

Last, we believe that with an additional groomed trail added to the Hyak Sno-Park this will help to disperse users across a wider area of varied terrain to help avoid user conflicts, reduce crowding, improve safety, and enhance the overall recreational experience of all outdoor winter recreationalists that would utilize it. All of these aspects support the Winter Recreation Program's Strategic Plan.

Yes, the regional area WRAC member John Baranoski has been included in the planning of this project for a number of years and has assisted with direction and reccomendations.



Dear WRAC Members,

The 170 member Washington State Ski Touring Club (WSTC) is writing to provide support for the Snoqualmie Nordic Club request for Priority 5 funding for the 1.5 mile "Jente Loppet Course" on USFS Boat Launch Road (NF 9070-219) for this coming winter. The proposed route is located on the summer Lake Keechelus Boat Launch access road which is a full width two lane paved roadway with shoulders, pullouts, two boat ramps leading to the Lakeshore, and a large parking area. In addition, the route utilizes the old USFS Lake Keechelus Trailhead with access to the Palouse to Cascades Trail at .5 miles south of Hyak Sno-Park with a large circular parking area and a two stall Vault toilet.

This trail is very popular with winter recreation activities including XC Skiing, Snowshoeing, Hiking, and provides the only safe and legal access to the frozen lake for ice skating and parasailing when conditions allow. The varied terrain and the expansive views draw many visitors to enjoy the panoramic views of the Cascade Range afforded by the open vista.

The Jente Loppet is an annual event staged by volunteers of the Snoqualmie Nordic Club (SNC) since 2011. The course was designed by Don Brooks founder of the SNC and Tim Becker a club Board Member with assistance from John Boone Badda the Washington State parks groomer who created the original course with a large loop along the shore of Lake Keechelus. The route is 1.06 miles long and would need to be groomed in both directions to create a wide path to provide lanes of travel for multiple user types as it is a very popular route for Nordic Skiers, Snowshoers, Boot hikers, Backcountry Mountaineers headed to Roaring Ridge, and for access to the lake for Parasailers. The wide roadway is ideal for accommodating the users coming from the Hyak Sno-Park which often fills on weekends.

Prior years requests for groomed funding has received enthusiastic support from USFS Land managers from the Mount Baker-Snoqualmie National Forest in North Bend, Steve Johnson, Nikolai Ferrell, and Brian McNeil, from Washington State Parks managers Jason Both, Andrew Kerlee, and John Ernster, and former Winter Program managers Pamela McConkey and Wayne McLaughlin.

The long-term plans are to incorporate the Jente Loppet Course into the regular grooming program for the Palouse to Cascades Trail to increase the winter recreation trail opportunities available at the popular Hyak Sno-Park, the most visited non-motorized facility in the Statewide system of Sno-parks. We feel that this proposal supports the goals of the Winter Recreation

Strategic Plan. We advocate for your consideration of the value this would bring to the users of the Sno-parks and ask that funding be provided.
