Affirm that land classification and long-term boundary decisions are for Commission policy direction only and should not affect private property values, be used as an indication of a property owner's willingness to sell or be used as a basis for making state or local government regulatory, permitting, or zoning decisions on private land holdings.
- 3. Affirm that any land acquisition or development of land management agreements within the adopted long-term park boundary are subject to staff capacity and agency priority.
